**TERMS AND CONDITIONS**

1. To use the water service on a month to month basis automatically renewing unless otherwise terminated upon due notice within a reasonable time by either party.
2. To advance payment to the ACWD an amount sufficient to cover service connection fee, tapping fee, application fee, etc. as per existing regulations:
3. To pay monthly to the ACWD office/ officer, the amount of water consumed with 2% *franchise tax* within *fifteen(15)* days from reading date of the water meter. We agree further to pay 10% penalty on our account if our water bill was not paid after due date. We agree further to pay additional collection charges on our overdue water bills and 2% surcharge on all overdue accounts if we fail to pay them *three (3)* days after due date. We finally agree that our service connection will be cut off *fifteen (15)* days after due date of my bill with a grace period of *three (3)* days for my failure to pay the necessary charges / and or the full amount of my water bills.
4. That upon perfection of this Application and Contract, and any time during the effectivity of the same, any employee and /or representative of the ACWD are hereby authorized to enter our premises to perform their official functions without necessarily committing any trespassing. To understand that the ACWD shall not be responsible for any interruption of service due to cause/s beyond its control.
5. To guarantee that no tapping will be made on our service pipe from the water main to water meter unless otherwise consented by both parties and further agree to maintain expenses of the same.
6. That we will not allow any sub-connection from our service pipe after our water meter nor allow peddling of the water from our service pipes and/ or faucets.
7. That ACWD will provide water meter for our service connection, we guarantee that we will be responsible for any loss, damage or tampering of the same. In case of loss or damage, we promise that we will pay it at a current price.
8. That in case we violate any term or condition of this contract or when the ACWD has reasonable ground to believe that we are using the water service in violation of its rules and regulations, this contract is deemed rescinded, thereby giving the ACWD the right to disconnect our water service even without prior notice.
9. That the excavation and installation of our service connection from the water main to water meter or any work appertaining thereto shall be done by the ACWD after payment of the necessary installation charges in accordance with the approved rates.
10. To submit us to the jurisdiction of the Court of Alaminos City, Pangasinan in case any court litigation arises out of this contract and to pay 10% Attorney's Fee but in no case less than Five Thousand Pesos (P5, 000.00) plus cost of suit.
11. That in case of court litigation arising out of this contract, to pay interest charges of 2% per month compounded monthly on our total unpaid water bills until the same has been fully paid which will take effect immediately upon filling.
12. That we shall accept such conditions of pressure and service as are provided by the distributing system at the location of the proposed connection, and shall agree not to hold the District blames for any damages arising out of low pressure or high pressure conditions or interruption of service.
