### RESOLUTION NO. 2018-B-01

#### DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF ONE (1) UNIT PICK UP TYPE SERVICE VEHICLE

**WHEREAS**, request for purchase **ONE (1) UNIT PICK UP TYPE SERVICE VEHICLE** with PR No.10805 was made on November 22, 2017 with an Approved Budget for the Contract amounting to One Million Five Hundred Thousand Pesos (Php1,500,000.00);

**WHEREAS**, the Committee resorted to Public Bidding pursuant to IRR of R.A. 9184, Section Section 10;

*"..Public Bidding or Competitive Bidding is a method of procurement which is open to participation by any interested party and which consists of the following processes: advertisement, pre-bid conference, eligibility screening of prospective bidders, receipt and opening of bids, evaluation of bids, post-qualification, and award of contract. ... "*

**WHEREAS**, the Committee Advertised and Posted an Invitation to Bid (ITB No.: ITB-08-2018-G) in the PhilGEPS on December 28, 2017 with Reference No. 5082736, in the ACWD website and in the conspicuous place of the District;

**WHEREAS**, from the ITB, Jessel and Jojo Trading registered in the Opportunity list but did not submit a Bid;

**WHEREAS**, Opening of Bid was scheduled on January 17, 2018 but no supplier submitted a bid;

**WHEREAS**, Section 35.1, paragraph "a" of RA 9184 states that, "The BAC shall declare the bidding a failure when: **a) No bids are received;** b) All prospective bidders are declared ineligible; c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or d) The bidder with the LCRB, HRRB, SCRB or SRRB refuses, without justifiable cause, to accept the award of contract, and no award is made in accordance with Section 40 of the Act and this IRR.


**NOW THEREFORE**, for and in consideration of the foregoing, this Committee **RESOLVE** as it is hereby **RESOLVED**;

- a) Declaring **FAILURE OF BIDDING** for the **PROCUREMENT OF ONE (1) UNIT PICK UP TYPE SERVICE VEHICLE**.
- b) To re-publish the Invitation to Bid in the PHILGEPS and the ACWD website.


