Invitation to Bid for the PROCUREMENT OF LABOR AND MATERIALS FOR INSTALLATION OF 8” PERMANENT BRIDGE CROSSING TRANSMISSION LINE AT EMBARCADERO BRIDGE, SADSARAN, POBLACION, ALAMINOS CITY

1. The **ALAMINOS CITY WATER DISTRICT**, through the *Corporate Budget 2019* intends to apply the sum of **One Million Three Hundred Eighty Nine Thousand Three Hundred Thirty Nine Pesos and 64/100 (Php1,389,339.64)** being the Approved Budget for the Contract (ABC) to payments under the to payments under the **PROCUREMENT OF LABOR AND MATERIALS FOR INSTALLATION OF 8” BLACK IRON (B.I.) PERMANENT BRIDGE CROSSING TRANSMISSION LINE AT EMBARCADERO BRIDGE, SADSARAN, POBLACION, ALAMINOS CITY.**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **ALAMINOS CITY WATER DISTRICT** now invites bids for **PROCUREMENT OF LABOR AND MATERIALS FOR INSTALLATION OF 8” PERMANENT BLACK IRON (B.I.) BRIDGE CROSSING TRANSMISSION LINE AT EMBARCADERO BRIDGE, SADSARAN, POBLACION, ALAMINOS CITY.** Completion of the Works is required *within one hundred twenty (120) Calendar Days from receipt of the Notice to Proceed (NTP).*

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **ALAMINOS CITY WATER DISTRICT** and inspect the Bidding Documents at the address given below **from 8:00AM to 5:00PM, Monday to Friday.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **June 7, 2019** through PhilGEPS website and from the address below and upon payment of the

applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Alaminos City Water District* will hold a **Pre-Bid Conference on June 17, 2019 2:00PM** at the **Conference Room, Alaminos City Water District, Poblacion, Alaminos City, Pangasinan** which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the **Conference Room, Alaminos City Water District, Poblacion, Alaminos City, Pangasinan on or before July 1, 2019, 1:30PM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **July 1, 2019, 1:31PM** at the **Conference Room, Alaminos City Water District, Poblacion, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Alaminos City Water District* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
