Invitation to Bid for the PROCUREMENT OF LABOR AND MATERIALS FOR INSTALLATION OF 10” TRANSMISSION LINE FROM CABATUAN PRODUCTION PLANT 3 TO MARCOS AVE. (IN FRONT OF BIR)-PHASE 1

1. The *ALAMINOS CITY WATER DISTRICT*, through the *Approved Corporate Budget 2018* intends to apply the sum of *Eleven Million One Hundred Thirty-Two Thousand Forty-One Pesos and 10/100 (Php11,132,041.10)* being the Approved Budget for the Contract (ABC) to payments under the.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *ALAMINOS CITY WATER DISTRICT* now invites bids for **the PROCUREMENT OF LABOR AND MATERIALS FOR INSTALLATION OF 10” TRANSMISSION LINE FROM CABATUAN PRODUCTION PLANT 3 TO MARCOS AVE. (IN FRONT OF BIR)-PHASE 1 (CABATUAN PH3 TO BALANGOBONG IN FRONT OF CANAL RICE MILL)**. Completion of the Works is required *within sixty (60) calendar days from receipt of the Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *ALAMINOS CITY WATER DISTRICT* and inspect the Bidding Documents at the address given below **from 8:00AM to 5:00PM, Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **March 08, 2018** through PhilGEPS website and from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Thousand Pesos (Php20,000.00):

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,

provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Alaminos City Water District (ACWD)* will hold a **Pre-Bid Conference on March 16, 2018, 1:30PM** at the *ACWD Conference Room, ACWD Main Building, Poblacion, Alaminos City, Pangasinan* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the at the *ACWD Conference Room, ACWD Main Building, Poblacion, Alaminos City, Pangasinan* on or before **March 28, 9:00AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **March 28, 2018, 9:01AM** at the *ACWD Conference Room, ACWD Main Building, Poblacion, Alaminos City, Pangasinan*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Alaminos City Water District* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
