INVITATION TO BID FOR THE PROCUREMENT OF ONE (1) UNIT PICK UP SERVICE VEHICLE

1. The **ALAMINOS CITY WATER DISTRICT**, through the *Corporate Budget for the Year 2018* intends to apply the sum of **One Million Pesos (Php1,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of One (1) Unit Multi-purpose Service Vehicle**. Bids received in excess of the ABC shall be automatically rejected at bid opening
2. The **ALAMINOS CITY WATER DISTRICT** now invites bids for the **Procurement of One (1) Unit Multi-purpose Service Vehicle**. Delivery of the Goods is required **within thirty (30) days from receipt of Notice to Proceed/Purchase Order**. Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **ALAMINOS CITY WATER DISTRICT** and inspect the Bidding Documents at the address given below during **Monday to Friday, 8:00AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 5, 2018** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00)*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **ALAMINOS CITY WATER DISTRICT** will hold a Pre-Bid Conference on **March 13, 2018, 1:30PM** at the **ACWD Conference Room, ACWD Main Building, Poblacion, Alaminos City, Pangasinan**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 26, 2018, 1:30PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **March 26, 2018, 1:31PM** at **ACWD Conference Room, ACWD Main Building, Poblacion, Alaminos City, Pangasinan**. Bids will be opened in the presence of the bidders' authorized representatives who choose to attend at the address below. Late bids shall not be accepted.

The **ALAMINOS CITY WATER DISTRICT** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
